A Meeting of NRMC was held under chairmanship of Secretary MoHUA on 8th August, 2017 at 2.30 P.M. at Nirman Bhawan, New Delhi. List of participants is annexed.

2. Secretary (HUA) welcomed all the participants. Shri Sanjay Kumar, JS (DAY-NULM) gave a brief presentation on the activities/ training programme being undertaken by the RCUES. Subsequently, discussions were held and Secretary (HUA) directed as follows:

a) 4 States and two UTs which are presently not under jurisdiction of any RCUES shall be allotted as under:-

b) The activities undertaken by various RCUES during the last Financial Year and the proposed Action Plan for the current Financial Year were reviewed. Since the RCUES, right now, are imparting capacity building and training programme in various Missions separately, it was decided that NIUA will coordinate along with the empanelled Training Institutions under AMRUT/Smart City and RCUES to prepare an Integrated Training Module for Swachh Bharat/NULM/PMAY and HRIDAY. The proposed module should draw upon the good and cost effective capacity building practices of various missions and a presentation will be made by NIUA on 15th September at 2.30 PM at the same venue. The empanelled agencies shall also be invited to the next meeting. The work plan to be allocated to each RCUES will be decided on the basis of Integrated Training Module.
