



CLIMATE CHANGE AND ITS IMPACT ON URBAN ENVIRONMENT

The Regional Centre organized a one day workshop on 'Climate Change and Its Impact on Urban Environment' for the officials of urban local governments, NGOs and Academicians on June 5th 2014 in Lucknow.

The main objectives of the workshop were:

- •To discuss the issues and dimensions of climate change and urban environment;
- •To highlight the causes and consequences of climate change in urban areas;
- •To discuss the dynamics of urban environment and its linkages with changing climate due to global warming;
- •To highlight the impact of climate change on natural disasters in urban areas;
- •To discuss the policy imperatives and legal framework for addressing climate change and its impact;
- •To suggest suitable policy measures for managing climate change and its impact in urban areas.

The programme was inaugurated by Dr. Anjuli Mishra, Joint Director, RCUES, Lucknow. In her inaugural address, she highlighted the need and importance of the subject of training programme. She said that climate change has vast impact on urban environment and therefore, urban local governments need to evolve suitable strategies for addressing the issues of climate change in the context of urban

TRAINING PROGRAMME ON RAINWATER HARVESTING

A two day training programme on Rain Water Harvesting was organized in Lucknow on August 5th & 6th,2014 for the officials of urban local bodies and Development Authorities of Uttar Pradesh.

The major objectives of the programme were as under:

- •To acquaint the participants with the grave situation arising out of the depleting ground water level.
- •To highlight the need and importance of water conservation and augmentation of the ground water resources;
- •To discuss the various techniques of rain water harvesting;
- •To emphasize upon the community and private sector participation in water conservation; and

The session was inaugurated by Sri A.K. Gupta, Additional Director of the Centre. During his interaction with the participants he emphasized that public participation is the most vital component for successful implementation of rainwater harvesting. He focused that the community needs to be educated and informed about the various techniques of water conservation. He encouraged the participants to motivate the citizens to check the misuse and wastage of water.

The participants of the training programme consisted of Junior Engineers of Development Authority, Junior and Assistant Engineers of Nagar Nigam of Uttar Pradesh. In all 21 participants participated in the programme.

TRAINING PROGRAMME ON PUBLIC PRIVATE PARTNERSHIP IN MUNICIPAL SERVICES

In order to derive the advantage inherent in public sector as well as private sector enterprises, the role of public- private partnership is considered to have great potential in some important areas in delivery of municipal services. The partnership fall into five main categories viz. (i) contract services; (ii) privatization of services; (iii) designing, constructions and operation of facilities; (iv) project financing & (v) merchant facilities. The partnership in municipal services is expected to reduce cost of maintenance, increase efficiency and timely completion of new projects while community participation in operation and maintenance of services is expected to be of great importance.

Keeping in view the importance of the above mentioned subject a two day Training Programme on "Public Private Partnership in Municipal Services" was organized by the Regional Centre, at Bhubaneswar w.e.f. 6th-7th August 2014.

The main objectives of the programme were:

- •To review the status of municipal services;
- •To acquaint the participants with need and importance of Public Private Partnerships in Urban Governance;
- •To assess the scope of public private partnership in delivery of municipal services;
- •To examine the role and scope for project financing by private-sector;
- •To highlight the importance and scope of privatization of services;
- To examine the problems, constraints and challenges in project financing and maintenance of municipal services;
- To suggest measures for enhancing the quality and efficiency in delivery of services and promoting equity as well as partnership in maintenance of municipal services.

The participants of the training programme consisted of Elected Representatives, Municipal Commissioner, Executive officers, Engineers and Experts of Odisha. In all 25 participants participated in the programme.

The programme was inaugurated by Sri Sanjib

Kumar Mishra, Director Municipal Administration, H&UD Department, Government of Odisha. Dr. Rajeev Narayan, Dy. Director & Course Director welcomed the guests & briefed about the programme.

The Chief guest Sri Sanjib Kumar Mishra, Director Municipal Administration, H&UD Department, Government of Odisha in his inaugural address said that as the local governments financial health is not good, hence providing good urban services & infrastructure it is necessary to have Public Private Partnerships. He further said that real PPP is in which the private sector invests funds and is not merely responsible for operation & maintenance of facility/service. He also informed that number of projects are being initiated in the state on PPP mode for e.g. Regional Landfill Site is being started for Bhubaneswar & Cuttack and Street Lighting at Bhubaneswar.

The major objectives of the programme were to highlight the problems of Urban Sanitation and its impact on urban environment; to examine the role of community participation in

Urban Sanitation, to discuss various strategies for designing effective urban WASH programme, to discuss National & State Sanitation policies, to orient participants regarding preparation & implementation of City Sanitation Plans. As part of the workshop the participants were taken for a field visit to study the successful model of treatment, reuse and recycle of waste water at NTPC Plant, Korba, Chhattisgarh.

WORKSHOP ON URBAN WATER SUPPLY & SEWERAGE MANAGEMENT

A two-day training programme on Urban Water Supply and Sewerage Management' for the officials of urban local governments at Patna on September 9-10, 2014. The main objectives of the training programme were as follows:

•To discuss the status, issues and challenges of urban water supply and sewerage management;

- •To highlight the water sector reforms and benchmarking of water supply and sewerage services;
- •To familiarize the participants with the concept of decentralized waste water treatment, recycling and reuse;
- •To assess the role of public private partnership in urban water supply and sewerage management;
- •To highlight the best practices on urban water supply, waste water treatment, sewerage services, public private partnership in water supply and sewerage projects and community participation in urban sanitation;
- •To suggest suitable technologies and policy measures for effective delivery of water and sewerage services by local governments.

The workshop was inaugurated by Shri A. K. Gupta, Additional Director, RCUES, Lucknow. In his inaugural address, he highlighted the relevance of water supply and sewerage management. He said that the municipal body should be service oriented rather than administrators.

In the programme, 31 municipal officials participated. Dr. Anjuli Mishra, Jt. Director with

A two day Regional level training programme on Urban Planning for Sustainable Development was organized by RCUES, Lucknow on September 16-17, 2014 at Ranchi, Jharkhand.

discuss the pertinent issues and dimensions of urban planning for sustainable development. Overall, 40 municipal officials including Executive Officers, Town Planners, and Engineers of urban local bodies and parastatal agencies participated in the programme.

The programme was inaugurated by Shri S. B. Mishra Deputy Secretary, Dept. of Urban Development, Government of Jharkhand. Shri P. K. Pal, Assistant Director, Dept. of Urban Development, Government of Jharkhand also graced the occasion.

Shri A. K. Gupta, Additional Director, Regional Centre for Urban and Environmental Studies, Lucknow, while addressing the participants and dignitaries of the programme, highlighted the growing importance of urban planning in the changing paradigms of urban development and governance, while Shri S. B. Mishra focused on the imperatives of urban planning as growing urbanization has posed challenges for urban planners.

The programme was coordinated by Dr. A. K. Singh, Assistant Director with active support of Mr. Himanshu Chandra, Assistant Director, RCUES, Lucknow.

MANAGING URBAN ENVIRONMENT

The immediate problems of Indian cities relate to inadequate institutional arrangements for solid waste management, drainage, sewage treatment and disposal and sanitation services. Thus, it is imperative to improve the municipal services, particularly sanitation services and urban local integrated governments adopt the planning for climate resilience and addressing the environmental problems. Against this view point, Regional Centre for Urban and Environmental Studies (RCUES), Lucknow, under the auspices of Ministry of Urban Development, Government of India, New Delhi organized a two training programme on Managing Environment for the Municipal Officials, Urban Planner and Engineers of urban governments for the State of Jharkhand from October 17th to 18th, 2014, at Ranchi.

In the programme, State government nominated

two officials from each urban local bodies of the state besides, ensuring participation of officials posted at secretariat level. Overall, 33 officials had participated in the programme

STATE LEVEL WORKSHOP ON MUNICIPAL RESOURCE MANAGEMENT & FINANCIAL MANAGEMENT

A two day training programme on "Municipal Resource Mobilization & Financial Management" was organized by the Regional Centre for Urban and Environmental Studies (RCUES), Lucknow for the senior municipal officials of Uttar Pradesh from October 29-30, 2014 at Lucknow.

The main objectives of the Workshop were:

- To throw light on the status of Municipal Finances in India and Need for Resource Mobilization.
- To discuss on the various Tax & Non-Tax Revenues sources of the ULBs and ways to enhance its potential.
- To orient the participants with roles of Central & State Finance Commissions in revenue mobilization of ULBs.
- To sensitize the participants towards mobilization of municipal resources through reforms in Property Tax.

- To sensitize the participants on role of GIS in enhancing municipal revenue
- To clarify the doubts / queries related to municipal resource mobilization.

The participants of the programme included Executive Officers, Tax officers and Accountants from Nagar Nigams, Nagar Palika Parishads and Jal Sansthans of Uttar Pradesh.

The programme was inaugurated by Sri A. K. Gupta, Additional Director, RCUES, Lucknow. In his inaugural address, he highlighted the relevance and importance of the topic of the workshop. He said concerted attempts need to be made for enhancing the resources of local bodies. In case of Nagar Nigams and class I local bodies, Geographical Information System (GIS) is the need of hours. Reforms are taking place in various cities but due to various local circumstances, the implementation is in various stages. The analysis in the cities has shown that there is much to learn from the good practices, which have led to visible system improvements. Bangalore has shown stark increase in percentage of property tax revenue collected, number of assessed properties and per capita tax collection after implementing area based assessment method.

Prior to, Dr. Anjuli Mishra, Joint Director, RCUES, Lucknow, highlighted the importance of capacity building of municipal officials for mobilization of municipal resources in urban local governments. She also outlined the programme and focused on intensive training to the municipal officials for effective implementation of Tax and Non Tax Revenue.

ENGENDERING BUDGETS AND GENDER INCLUSIVE URBAN DEVELOPMENT

Gender budgeting has been internationally recognized as a key tool for empowering women by incorporating gender perspective and concerns at all levels and stages of development planning, policy, programmes and delivery mechanism. Government of India has adopted budgeting for gender equity as a mission statement and is widely disseminating tools and strategies across ministries and departments. In view of the above, a three -day state level workshop was organized under the auspices of Ministry of Women and Child Development, Government of India, by RCUES, Lucknow on November 6-8, 2014 at Lucknow to discuss and deliberate on pertinent issues of engendering urban development and gender budgeting. Prof. Nishith Rai, Director, RCUES, Lucknow inaugurated the workshop. In his inaugural address, Prof. Rai highlighted the need and importance of topic of the workshop. He further said that Ministry of Urban Development, Government of India has introduced a scheme for training of women counselors on sharing basis with the concerned states but the states are not coming forward.

Shri A. K. Gupta, Additional Director, RCUES, Lucknow highlighted the imperative need of engendering urban planning for infrastructure development and delivery of civic services. Prof. Vibhuti Patel, SNDT Women's University, Mumbai and Prof. Darshini Mahadevia CEPT University Ahmedabad delivered a session on engendering urban governance, Gender budgeting in Municipal administration and

planning for urban infrastructure and services in gender perspective.

In the programme, 52 Officials from ULBs, Directorate of Urban Local Bodies, Jal Sansthans, Development Authorities, U.P State Social Welfare Board and representatives from civil society organization participated.

Dr. A.K. Singh, Assistant Director, with active support of Shri Himanshu Chandra, Assistant Director, RCUES, coordinated the programme.

REGIONAL TRAINING PROGRAMME ON MANAGEMENT OF URBAN ENVIRONMENT THROUGH SOLID WASTE MANAGEMENT

The issue of solid waste management had been given significant importance in both the schemes of JNNURM, UDISSMT and now in Swachh Bharat Mission. Most of the cities have developed detailed project reports for effective of management solid waste but it has been observed in some cases that due to lack of awareness and initiative the sanctioned projects are not being implemented effectively. Further Govt. of India has also come out with draft MSW Rules 2014.


