#### WORKSHOP ON UTTAR PRADESH STATE SEPTAGE POLICY & USED WATER MANAGEMENT

#### **BACKGROUND:**

As a step towards achieving improved sanitation in urban areas of the state, the Urban Development Department of the GoUP has formulated "Uttar Management Pradesh State Septage Policy" (UPSSMP) which was approved by the Cabinet on 23 October 2019 in line with the National Policy on Faecal Sludge and Septage Management, 2017. This is a landmark resolve of the Government to improve the urban sanitation so as to achieve outcome levels impact on public health, environment quality and human dignity. The policy addresses much required guidance and directions to achieve the targets as laid out in the ODF++ and lends sustainability to the ODF status achieved under Swachh Bharat Mission (SBM) - Urban 2.0. On October 1, 2021 the Ministry of Housing and Urban Affairs (MoHUA), Government of India launched Swachh Bharat Mission-Urban 2.0. The aim of this mission is to make ODF sustainable (ODF++) and ensure 100% used water (wastewater) is treated for reuse. The SBM 2.0 emphasizes on Used Water Management with special focus of Faecal Sludge & Septage Management as a new component.

Nonetheless, stakeholders from ULBs may need help in deciphering the technical aspects of these Policy and operational guidelines. The referred Septage Policy and the Used Water Management component under SBM 2.0 have laid out clearly the implementation plan with time bound achievement of the targets. The workshops on Septage Management Policy and Used Water Management are a first step towards capacity building of all ULBs of Uttar Pradesh and implementation of this policy and SBM



Their brains develop at a faster rate than at any other point in life, and their experiences have a long-term impact on their physical and mental health, as well as their ability to learn and relate to others. One of the most crucial aspects of a healthy, peaceful, and creative society and country is a decent start for all children. The relationships that an infant or toddler has with the adults in their lives have the greatest impact on their development. These individuals are in charge of a child's safety and wellbeing, as well as what they eat and how they view the

#### INTERNATIONAL WORKSHOP ON "PLASTIC WASTE MANAGEMENT" ON THE OCCASION OF WORLD ENVIRONMENT DAY

#### BACKGROUND

The environmental degradation and serious ecological imbalances are posing threat to mankind. The present development paradigms have posed a serious threat to environment and ecology, thus causing concern for sustainability of development. The environmental problems viz. global warming, destruction of ozone layer, extinction of species, loss of genetic diversity, deforestation, land degradation, acid rain, and deteriorating quality of urban environment are growing rapidly. Deforestation, un- sustainable agricultural practices, tourists' inflow beyond carrying capacity and also development of infrastructure on the cost of environment and ecology are causing environment crisis. Growing urban population and anthropogenic activities have widely affected the urban environment and sustainability of natural resources.

World Environment Day is celebrated annually on June 5th since 1973 and it is an occasion that brings together people from all over the world to take action for the environment. Ministry of Environment, Forest and Climate Change, Government of India has announced that World Environment Day 2023 will be celebrated with a focus on the Mission LiFE, which stands for Lifestyle for Environment. The aim is to encourage people to adopt sustainable lifestyle practices to protect the environment. The concept of LiFE was introduced by the Prime Minister of India at the 2021 in United Nations Climate Change Conference (COP26) in Glasgow. He called for a global effort to adopt sustainable lifestyle practices, and since then, India has been mobilizing people to embrace LiFE. World Environment Day 2023 is hosted by Côte d'Ivoire and supported by the Netherlands and the theme will focus on solutions to plastic pollution under the campaign "Beat Plastic Pollution." The changing lifestyle of humankind has caused concern as resources are depleting, degrading and adverse towards harmony with nature. Rapid expansion of urban areas present fundamental

challenges but there are also opportunities to restore ecological functions to design more liveable, healthy and resilient cities. Thus, it is imperative to bring transformative changes through policies, action and sustainable lifestyles towards clean, green and climate resilient cities. Against this backdrop, RCUES, Lucknow, in collaboration with Center for People & Environ (CPE), Bangladesh, Ecobricks Alliance, Indonesia, GFSRD, Malaysia, Global Centre for Rural Urban Linkages Studies, and CosmoMinds, India proposes to organize International Workshop on "Plastic Waste Management" on the occasion of Word Environment Day 05 June, 2023.

#### TRAINING PROGRAMME ON MANAGEMENT OF BIOSOLIDS IN ULBS

#### BACKGROUND

Around 65% of the urban population in India does not have access to sewerage network and is dependent on onsite sanitation systems (OSS), which generates tonnes of Fecal matter which further needs proper treatment.

With the launch of SBM, India's focus has drastically shifted to not only toilet construction but also Safe disposal and treatment of Fecal sludge so that it does not contaminate the environment.

The situation is no different in Uttar Pradesh, a state where state septage management policy was issued in 2019 and the state decided to implement FSTPs. With 3 FSTPs in force and around 59 new FSTPs and Cotreatment facilities in pipeline (as of 2021), UP's Fecal Sludge management journey has come a long way. A critical link in faecal sludge and septage management (FSSM) value chain is reuse of the byproducts generated from FSTPs, which include treated water as well as biosolids. Manure is not the only resource which can be recovered from excreta. The faecal sludge also contains organic carbon that can be used to generate energy in the form of heat or electricity — the calorific value of faecal sludge is as high as many other commonly used organic fuels.

The reuse of biosolids or manure, has huge potential in agrarian states like Uttar Pradesh with the commissioning of various FSTPs being implemented in major cities in Uttar Pradesh.

With limited knowledge, nascent regulatory framework, and lack of awareness the issue of biosolid use has taken a backstage in case of India and particularly for Uttar Pradesh. With majorly an agrarian economy where farmers are largely dependent on fertilizers, biosolid use can make a great case for the state of Uttar Pradesh where these Biosolids may be spread over land for plant fertilization and soil conditioning and showcase a huge potential.

This resource recovery and reuse will help the ULBs in shifting the focus from waste being regarded as something to be disposed to waste being regarded as a valuable resource especially for farming and move towards a more circular economy. In this context, Regional Centre for Urban and Environmental Studies (RCUES) Lucknow successfully conducted two, Training Programmes on Management of Bio solids.

#### **OBJECTIVES**

The training aims to sensitize the officials on the importance of Biosolids, regulatory framework, quality controls in biosolids, existing international standards and framework, potential uses of biosolids, revenue generation.

#### SESSIONS

- Introduction to the Training- The session involved introduction of the participants and mapping their expectations from the training, introduction of Training schedule, knowledge mapping and training expectations,
- UP-FSSM Journey- issues, challenges, and success stories- This session discussed on Status of Fecal Sludge Management in Uttar Pradesh, UP-FSSM policy framework, Status of existing FSTPs and Cotreatment plants, Status of Proposed FSTPs and Cotreatment Plants, Issues of FSM in UP
- Circular economy in Water- Introduction to the concept of circular economy along with understanding the WICER regulatory framework.
- Introduction to Biosolids- introduction to the concept of Biosolids, its characteristics, Components of biosolids- useful and harmful. The session will also include Importance of biosolids- farm use, climate change. Soil rejuvenation and Importance of Biosolids in UP context
- Regulatory framework for Biosolid use- introduction and understanding of the Regulatory framework for



Biosolid use worldwide, its application and relevance in Indian context

- Field visit Visit to STP and farmland using Biosolids.
  Field visit to Daulat Ganj 56 MLD sewage treatment plant to understand its functioning and the generation of Biosolids and aspects of its use in the area
- Treatment methods for biosolids- Discussion on the various treatment methods for Biosolids including Heat, Chemical, Storage and Incineration. With case studies, this also included a detailed discussion on the various treatment options available like Heat, Chemical, Storage and Incineration

#### ORIENTATION TRAINING PROGRAMME UNDER AMRUT 2.0 FOR UTTARAKHAND OFFICIALS

#### BACKGROUND

AMRUT 2.0 is a step towards AatmaNirbhar Bharat with aim of making the cities 'water secure' and providing functional water tap connections to all households. This will be achieved through circular economy of water by effecting water source conservation, rejuvenation of water bodies and wells, recycle/ reuse of treated used water, and rainwater harvesting by involving community at large. This Mission will be run as people's program i.e. Jan Aandolan. Mission also targets to provide 100% sewage/ septage management in 500 AMRUT cities. Mission will focus on empowering States/ UTs and cities for efficient implementation of projects in the spirit of cooperative and competitive federalism by providing flexibility to the States/ UTs to formulate, plan and implement the projects. CA released can be utilized for projects in any of the ULBs as per physical/ financial progress of the projects. In this context, Regional Centre for Urban and Environmental Studies (RCUES) Lucknow successfully conducted the 3 day Orientation Training Programme under Atal Mission for Rejuvenation and Urban Transformation 2.0 for municipal functionaries of Uttarakhand state from 19th to 21st June 2023 at Lucknow.

# The three days training was designed to enhance the functional knowledge and improve the job-related skills for effective implementation of the scheme. The programme was designed to orient the participants with AMRUT 1.0 achievements and give a broad overview of AMRUT 2.0, to acquaint the participants with admissible Elements of Projects, Reforms Agenda to be achieved and different Action Plans to be prepared under AMRUT 2.0.

Over the course of three days the programme focused on the city level strategies for Recycle & Reuse of Treated Used Water and City level action plan for Rejuvenation of Water Bodies (including Urban Wetland) & Creation of Green Spaces and Rain Water Harvesting, discuss about Pey Jal Survekshan toolkit to ascertain equitable distribution of water, reuse of wastewater and mapping of water bodies and to prepare the ULB officials for undertaking Survekshan.

#### **ONLINE TRAINING ON PROJECT MANAGEMENT, CONTRACT MANAGEMENT & PUBLIC PRIVATE PARTNERSHIP**


#### BACKGROUND

Urban India has grown by nearly five times during the last fifty years, while the population of India has grown two and half times in the same period. India's Urban Population grew from reported 290 million in Census 2001 to an estimated 340 million in 2008. This process of urbanization has created a huge gap between demand and supply of urban services and infrastructure.

Contract Management is important throughout the entire process of the contract cycle and not just at award process, effective contract management will bear dividends for both employer and contractor to ensure a well-managed agreement in practical and logistical terms. Contracts, the foundation to every business relationship, are a legally binding agreement

between the parties identified in the agreement to fulfil all the terms and conditions outlined in the agreement. A prerequisite requirement for the enforcement of a contract, amongst other things, is the condition that all the parties to the contract accept the terms of the claimed contract. One who is in charge of the project is known as the Employer. One who agrees to execute or perform is known as the Contractor.

Project management is the application of processes, methods, skills, knowledge and experience to achieve specific project objectives according to the project acceptance criteria within agreed parameters. Project management has final deliverables that are constrained to a finite timescale and budget. A project manager is the person responsible for leading a project from its inception to execution. This includes planning, execution and managing the people, resources and

scope of the project.

Rapid urbanization and growing demand has increased the need for investment in infrastructure development. Limited availability of funds for the provision of infrastructure has widened the divide between requirements and supply. The investment requirement far exceeds the availability of budgetary allocation. The government therefore has been encouraging PPPs to attract market investment, thereby leveraging government budgetary resources to meet the provisions for infrastructure.

Against this view point, Regional Centre for Urban and Environmental Studies (RCUES), Lucknow, under the auspices of Ministry of Housing and Urban Affairs, Government of India, New Delhi organized an Online workshop on Project Management, Contract Management and Public Private Partnership for the Municipal Officials, Urban Planner and Urban Infrastructure Expert of Urban Local Bodies on 24th June 2023.



#### BACKGROUND

Gender budgeting has emerged as an important instrument for gender mainstream and women empowerment across the globe. It has been well recognized by the policy makers and feminist economists that gender budgeting is imperative for gender equality and engendering development planning.

Gender budgeting refers to the systematic examination of the budget programmes and policies for the impact on women. Studies show that programmes and policies design to improve women's economic opportunities lead to higher rates of economic growth.

Gender budgeting has gained prominence in the policy circles in the recent years. In view of the growing importance of the gender budgeting, the present study purports to critically review the plans, policies, programmes and schemes and also to examine union budgets through gender lens. In 1984, Austria introduced the first gender budget. Taking budgets as essential instruments for promoting gender equality, pioneering analysis of the impact of public budgets on gender relations was carried out. Since then, more than 90 countries have adopted gender budgeting as a tool empowerment for women and engendering development. In India too, many states, local governments, corporate houses and private agencies have initiated gender budgeting and have introduced specific policies, programmes and schemes for gender mainstreaming. In view of the above, two Online workshops on Gender Inclusive Participatory Planning & Decision Making.

#### **Objectives of Workshop:**

- To review the rationale of the gender budgeting as a tool for women empowerment and also to discuss strategic framework of gender budgeting activities;





